NOTICE IS HEREBY GIVEN TO THE REGISTERED QUALIFIED VOTERS OF THE REORGANIZED SCHOOL DISTRICT NO. 4 OF JACKSON COUNTY, MISSOURI, THAT THE BOARD OF EDUCATION OF SAID SCHOOL DISTRICT CALLED A SPECIAL ELECTION TO BE HELD IN THE DISTRICT ON TUESDAY, FEBRUARY 6, 2024. SHALL REORGANIZED SCHOOL DISTRICT NO. 4 OF JACKSON COUNTY, MISSOURI (BLUE SPRINGS, MISSOURI), ISSUE ITS GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$100,000,000 FOR THE PURPOSE OF CONSTRUCTING A CAREER AND INNOVATION CENTER, CONSTRUCTING PERFORMING ARTS FACILITIES AT EACH MIDDLE SCHOOL THAT WILL ALSO SERVE AS STORM SHELTERS, CONSTRUCTING CLASSROOM ADDITIONS AT CERTAIN ELEMENTARY SCHOOLS AND ACQUIRING, CONSTRUCTING, IMPROVING, EXTENDING, REPAIRING, REMODELING, RENOVATING, FURNISHING AND EQUIPPING NEW AND EXISTING SCHOOL FACILITIES AND ACQUIRING LAND THEREFOR?

**NOTICE OF ACCESSIBILITY**

FURTHER NOTICE IS GIVEN THAT, WHERE A REGULAR POLLING PLACE HAS LIMITED ACCESSIBILITY, A DISABLED OR ELDERLY VOTER MAY BE PROVIDED AN ALTERNATIVE MEANS OF CASTING HIS OR HER BALLOT. SUCH MEANS MAY INCLUDE REASSIGNMENT TO AN ACCESSIBLE POLLING PLACE, CURBSIDE VOTING, ASSISTED VOTING OR VOTING BY ABSENTEE BALLOT. A VOTER MAY APPLY FOR AN ABSENTEE BALLOT IN PERSON OR BY MAIL, OR MAY HAVE A RELATIVE OR GUARDIAN APPLY IN PERSON ON HIS OR HER BEHALF. IF AN ABSENTEE VOTER IS DISABLED OR INCAPACITATED, THE NOTARY REQUIREMENT IS WAIVED. IN ADDITION, VOTERS REQUIRING ASSISTANCE MAY BE ASSISTED BY A PERSON OF THE VOTER'S CHOICE.
